It is understood that any and all proofs, sample prints, and digital negatives remain property of Natan Vigna Photography/Natan Vigna, and they may be used for advertising, display, or any purpose thought proper by Natan Vigna Photography/Natan Vigna or its agents.

2. Although all care will be taken with the negatives and photographs taken at the wedding, Natan Vigna Photography limits any liability for loss, damage, or failure to deliver pictures for any reason ONLY to the return of all deposits and payments made.

3. It is understood that no other photographer shall be hired to photograph at the wedding while Natan Vigna Photography, along with any of its assistant(s) is working, and that any breach of this agreement will constitute a reason for non-compliance of the job with no liability to Natan Vigna Photography and loss of initial deposit by signing party. (Family members and guests attending the wedding/event are allowed to take pictures!)

4. Upon signature and payment of deposit, Natan Vigna Photography will reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, all deposits are non-refundable, even if date is changed, or wedding is cancelled for any reason.

5. With packages, a deposit of 1/3<sup>rd</sup> is due at signing of this contract to reserve the date; 1/3<sup>rd</sup> to be paid one month prior to wedding and the remainder to be paid two weeks before the wedding. All terms of this agreement are understood and agreed upon.
